### Regular Meeting April 9, 2013

Attorney Doug Arthur reported on the blight ordinance. He stated we have a very small authority unless there is a danger to the safety, health or welfare of the citizens. A letter could be written stating the Town has received some complaints and as a good neighbor, encourage them to clean up their property. Town Manager Clark Draper stated he does not like to write letters that imply we have more authority than we have. Councilman Holtzman asked about removing old vehicles that people feel are their treasures. Attorney Arthur stated there is a state statue that allows a Town to have removed unlicensed vehicles.

Town Manager Clark Draper stated there was a sewer backup on Broad St. on Sunday night. The Town employees responded to the incident. The residents of the house are staying at the motel. We are working on it with the insurance company. The backup was in two houses. There was a grease clog in the sewer line.

Councilman Shepherd reported the Finance Director and the Town Manager did a very good job on the budget preparation.

Councilman Holtzman thanked Town Manager Clark Draper and Town Attorney Doug Arthur for the research on the issue in question.
