<u>Town Manager Report</u>: Kevin Fauber stated in his report that Town Clerk Heather Taylor received the Region III VMCA Clerk of the Year award for 2016. The award was presented to Heather by Erica Kann from the City of Harrisonburg. Heather Taylor did a short presentation describing the conferences she attends as she works towards becoming certified as a Municipal Clerk for the town of Mount Jackson and expressed her gratitude for the support received.

Committee Reports:

Councilmember Shepherd, chair of the Finance Committee stated that the town's total debt of almost \$5.7M is healthy for a town of our size.

Councilmember Rudy, chair of the Public Safety Committee stated that service calls with the police department increased by 200 calls from December to January due to self-initiated calls. There were no open windows or doors found this month. Of the 8 criminal offenses, 5 are closed, 1 is under investigation and 2 required the officers to do mental assessments. Councilmember Rudy also reported that the Rescue & Fire Banquet was well attended and very successful.

Councilmember Hackenbracht, chair of the Public Services Committee reported that the town has been working with an engineer since March of 2016 to replace two types of old pipe within town limits. The repair work will be done in phases so as not to disrupt service to the

community. One line runs along the west side of Rt. 11 and the other runs diagonally from Well 2 under the soccer field. More information is being collected on this project and which will be brought back to Council for further discussion and action.
