<u>Hear from Visitors:</u> Candi Lopresti, 5146 Dogwood Drive, I would like to thank Councilmember Shepherd for the Halloween Pictures he took of the town, the houses, the kids and posted it on social media what a small town looks like it was absolutely wonderful. My other item is the sidewalks, have you heard anything from VDOT yet? Kevin Fauber, Town Manager spoke, I know they have reached out to our engineer on some questions they have. The VDOT representative is out of the Staunton District Office and contacted our engineer a couple of weeks ago, he had some questions as he is working on the agreements. We feel the agreements are imminent, they should be here soon. That will lead us into our meeting with the VDOT Officials. Candi Lopresti, we still do not have date? Town Manager responded, no. <u>Town Manger Report</u>: We started the Well Project, we have had some meetings over the course of last week. The contractor is getting mobilized, working on the submittals for the equipment to be approved, getting equipment ordered. They want to get the concrete slap in before the cool weather so they can set the building and work inside the building this winter. The contract time on the project is a year from October.

<u>Committee Reports:</u> Finance Committee Chairperson, Rod Shepherd, we will have the Auditors in the house in about 3 weeks.

Personnel Committee Chairperson, Roger Rudy, the position that is available within the Town Staff which is now becoming known as the Clerk of Council/Administration Assistant. That position was advertised shortly after our last meeting. It generated thirty-two applications. The Town Manager and the Finance Director reviewed the applications and narrow it down to 3 candidates which they felt brought the skills needed to that position. Last week, I joined the Town Manager and the Finance Director in the preliminary interviews with those three candidates. It was our decision we put these three candidates forward to a second interview that would involve the full Personnel Committee. Those interviews are scheduled this Thursday evening. We should have a decision made by Thanksgiving.

Public Safety Committee Chairperson, Judy Fultz reported the Police Department for October totaled 513 calls up 90 from September. There were 8 Criminal Offenses, 6 have been cleared or closed, 2 under investigation. There were 7 open doors/windows at 7 different locations. Rescue & Fire report for October the total responses for 68, total EMS responses 46, total fire responses 22, 72% of total responses by volunteer crews. The breakfast with Santa is Saturday December 8th. David Brinegar spoke, we had training for "Active Shooter" with the police and other agencies. The biggest issue with an Active Shooter is people die because they basically bleed out, our goal is finding the people and stop the bleeding onsite then remove outside. We are now equipped with 28 Active Shooter bags on our units.
