## Regular Meeting June 10, 2014

The regular meeting of the Mount Jackson Town Council was held on June 10, 2014 at 7:30 PM in Council Chambers at 5901 Main Street. The following were in attendance: Kay Whetzel, Vice Mayor and the following Council members: Dennis Andrick, Ken Hackenbracht, Todd Holtzman, Donnie Pifer, and Rod Shepherd. Absent: Mike Koontz, Mayor. Also in attendance: Doug Arthur, Town Attorney, Kevin Fauber, Town Manager, Neil Showalter, Finance Director, Judy Fultz, Clerk and Heather Taylor, Deputy Clerk. Visitors present included newly elected Mayor, Bucky Miller as well as Councilmembers, Whitney Miller and Roger Rudy. Councilman Donnie Pifer's son, Duane Pifer and grandson, Colin Pifer. Ryan Cornwell, reporter from the Northern Virginia Daily newspaper was present.

Councilman Shepherd called the meeting to order at 7:30 PM and led the meeting as requested by Vice Mayor Whetzel. He began the meeting stating that he was touched to be asked to fill in at this time. This meeting specifically would have been Mayor William's last meeting for his term. Councilman Shepherd reminded the newly elected members to be sworn in by the office of the Circuit Court Clerk and to turn the documents in to the town for filing. He also mentioned that staff is available to answer questions and give conference and mail information to the newly elected councilmembers.

Councilmen Hackenbracht and Shepherd recognized the service time of councilmembers Whetzel and Holtzman whose terms will end June 30, 2014. Hand-crafted platters made by local potter, Kary Haun of Woodstock were presented at this time.
