<u>Town Manager Report:</u> Kevin Fauber reported that he has received the construction permit from the health dept. for the well project. He also reported that VDOT has given the go ahead for the bidding on the sidewalk project. Dates are being put together for the bids to take place.

Committee Reports:

Chairman Shepherd from the Finance committee reported that the auditors have postponed the audit until April.

Chairman Rudy from the Public Safety committee reported that the police department had 70 more calls than February, an increase of 10.5%. Of the 13 criminal offenses for the month, 7 have been investigated and 5 have been cleared. There were 4 open windows/doors found by officers on patrol. The Mount Jackson Rescue & Fire Dept. had a total of 63 responses last month, 39 of which were responded by EMS and 24 were fire responses. Ninety-five percent of the calls
