Four visitors spoke to show their disapproval/approval of the Whitehurst Rezoning request on Turkey Knob Road.

Gary Lantz reiterated his disapproval mentioning there would be consequences to the environment as well as to taxes and he also stated that the revenue would not equal the loss. The land is not well suited to Industrial use.

Bill Holtzman spoke with approval of the project stating that this land is an opportunity for growth that offers natural resources. This opens doors for our young people and he implored Council to be in support of this project.

Steve Stein requested that the Council seek diversity with the project and to not put all "the eggs in one basket". Mr. Stein also requested that two letters be included with these minutes. A letter dated 4/9/15, from the Commonwealth of Virginia-VDOT, District Planning Manager, Terry Short Jr. and the second letter dated 3/25/15, from Matthew Smith, Area Land Use Engineer from the Commonwealth of Virginia-VDOT. Copies of these letters are included with these minutes.

Todd Holtzman spoke to the Council and is in favor of this project stating that this is a tremendous opportunity for the town. Change is scary but he trusts the town government, Special Use permit, town

body and the set requirements. Mr. Holtzman highlighted what the County Seal states, "Industry with Plenty," and he thanked the Council for their good judgement.

Mayor Miller thanked the people who spoke and shared their thoughts and concerns. The basketball courts at Lion's Club Park will be resurfaced in this budget cycle. A date has not been set yet but it will be done this summer. Opening Day for the Mount Jackson, New Market Little League was held recently. It was well attended. Mayor Miller encouraged everyone to take a look at the ball field and how nice a space it is.

Councilman Andrick has plans, as the Chair of the Ordinance committee, to go on a Ride-Along with a police officer in the near future. He is also planning on meeting with staff to form a better plan on collecting delinquent taxes.

The Public Safety Chair is Councilman Rudy and his report included in the month of March the police department had 410 calls with 80 offenses. Six were cleared, 1 is closed and 1 remains active. The officers did 150 property checks. Rescue and Fire ran 74 calls for the month. The fund drive will be next month. The Rescue and Fire dept. took ownership of a new ambulance and received a 1998 Dodge pickup from Great Falls Volunteer Fire Department.

Chair from the Public Properties Committee, Councilperson Miller commented on Opening Day at the ball park being a great day. There was a good show by staff and volunteers.
