We would like to develop well #7 and well #8 and build a tank to blend them. We have been having nitrate issues from well #4 and issues from well #2. There would need to be a rate increase of \$0.31 cents per 1000 gallons of water. In the current fiscal year budget there is included money to run electricity to well #7.
