Regular Meeting March 13, 2012

The regular meeting of the Mount Jackson Town Council was held on March 13, 2012 at 7:30 p.m. in the basement conference room at 5901 Main Street. Roll call was taken with the following in attendance: Neil Fadely, Kenneth Hackenbracht, Todd Holtzman, J. Bucky Miller, Rodney Shepherd, and Kay P. Whetzel, Councilmembers. Absent: Joseph Williams, Mayor. Also present: Doug Arthur, Town Attorney, Charles Moore, Town Manager, Clark Draper, Assistant Town Manager, Neil Showalter, Finance Director, and Judy Fultz, Clerk. Visitors present: Donna Wolfe.

Councilman Miller stated he is not seeking a third term on the Council. He stated he gave a story to the Northern Virginia Daily.

COMMITTEE REPORTS:

Councilman Shepherd, Chairman of the Finance Committee, reported the Town has been accepting credit card payments. This is causing some extra work on the bank reconciliation. The Town is looking into the matter of adding a fee to the customer. Other towns are also considering charging a fee. This matter will be discussed at a later date.

Councilmember Whetzel, Chairman of the Public Safety Committee, reported the police department has received 303 calls for service in February. Criminal offenses reported were 1 Simple Assault (cleared by arrest), 1 Aggravated Malicious Wounding (cleared by arrest), 1 Assault Family Member (cleared by arrest), 1 Auto Theft (cleared by arrest), 2 Child Abuse (cleared by arrest), 1 Unlawful Entry (cleared by arrest), and 1 Fugitive from Justice (cleared by arrest). Sgt. Sterner has been released to report back to full duty on March 5. Auxiliary personnel worked 20 hours and assisted on 19 calls for service. Foot patrol was done on Main St. 19 times and one open door was found. The Police Department received a letter complimenting the Police Department on their extraordinary courtesy by an officer. This was determined to be Sgt. Sterner.

Councilman Hackenbracht, Chairman of the Public Services Committee, reported the committee had met a week ago. They discussed the painting of the water tower and possibly using Hargrove Graphics. They discussed Well #7 and #8, and advised we have applied for a grant to get the wells on line.

Assistant Town Manager Draper presented Ordinance O-03-2012 – An Ordinance to Amend Sections 66-3 and 66-335 of the Code of the Town of Mount Jackson Regulating Signs. The most significant changes are: 1- Definition and regulation of signs with electronic features, 2- Increased emphasis on Monument signs when signs are freestanding, 3- Emphasis on signs having the name of the business on them rather than generic products signs such as the 'throwaway' signs attached to light poles in shopping centers, 4- Allowing freestanding signs in the B-1 Zone which apparently had been overlooked in the past codes or was inadvertently deleted in the past, and 5-Simplification of some of the sign area calculations and standardization of area requirements.
