Public Hearings May 14, 2013

Several public hearings were held by the Mount Jackson Town Council on May 14, 2013 at 7:30 p.m. in Council Chambers at 5901 Main Street. The first hearing was Budget Amendment – Resolution R-01-2013, Amending Fiscal Year 2013 Budget. There were no comments from the public.

The second hearing was Annual Budget – Ordinance O-02-2013, Fiscal Year 2014 Budget – An Ordinance Adopting Budgets for the General Fund, Utilities Funds, Capital Projects, and Equipment Replacement Funds; Establishing Real and Personal Property Tax Rates, Establishing Compensation Amounts/Rates, Setting Fees for Water, Sewer, Refuse Service, Auto License Tax, and Other Fees, Charges, Penalties, and Taxes, and Establishing Annual and Specific Appropriations for Fiscal Year 2014. Councilman Shepherd stated staff did a remarkable job preparing the budget. There were no comments from the public.

The third hearing was Resolution R-02-2013 – Approval of Northern Shenandoah Valley Regional Commission's Hazard Mitigation Plan. The Northern Shenandoah Valley Regional Commission consists of City of Winchester, Counties of Clark, Frederick, Page, Shenandoah, and Warren. Each town is required to have a public hearing. There were no comments from the public.

Councilmember Whetzel, Chairman of the Public Safety Committee, reported Officer Himelright has completed his re-certification and has been released to work alone. Officer Vann is on vacation until his retirement July 1, 2013. Foot patrol was worked 27 times in April and one door was found open.

Town Manager Moore presented Special Use Permit application from Valley Building Supply for 124 Center Street for operation of contractors' equipment and storage yard, and accessory office use pursuant to Sections 66-262(b) (14) and (24) respectively of the Zoning Ordinance of Mount Jackson, Virginia. A public hearing was advertised and held on May 6, 2013. The applicant has added considerable landscaping since the public hearing. They will add significant landscaping to Rt. 11. They will have live screening in the rear of the property but not Leyland Cypress. The landscaping is to be completed by June 15, 2013. Motion by Councilman Hackenbracht and second by Councilman Holtzman to approve the Special Use Permit for Valley Building Supply located at 124 Center Street for the operation of Contractors' equipment and storage yard, and accessory office use pursuant to Sections 66-262 (b) (14) and 24) respectively of the Zoning Ordinance of Mount Jackson, Virginia with the following additional conditions: 1- Side of property facing Main Street shall be fully screened with alternating Leyland Cypress trees on 6 foot centers. This row of trees is to be behind the existing flowering trees so as to allow the flowering trees to grow successfully and create a color contract in spring. 2-In the rear of the property adjoining lots 6a and 6b a six-foot live screen is to be planted, but it is not to be Leyland Cypress which grows too high. The screen should be evergreens that are blight resistant and grow no higher than 10-12 feet. 3- Planting of landscaping is to begin within 2 weeks of approval and be completed by June 15, 2013.
