Survey work and minor issues/changes to the plans on the north end sidewalk project will be completed. the week of 5/22/15 which will then go to VDOT. It can then go out to bid. In regard to the Family Dollar project, the steel framework went up this week.

Councilman Rudy, Chair of the Public Safety Committee, reported that the Police Department answered 426 calls last month with 5 offenses and one is still active. Each police officer on the force now carries a body camera. The Rescue and Fire Dept. building is moving along. The Chief hopes to bring the new ambulance to the next council meeting in June for council to have a tour of that equipment.
