<u>Visitors</u>: Kenna Fansler from the Mount Jackson Museum reported that the sign from the Virginia Department of Historical Markers has been installed and Council members are invited to attend the dedication scheduled for 7/8/17 at 10:00 a.m. in Mayor's Park. Micah Miller, from the Mount Jackson Little League team, thanked the Town of Mount Jackson for their sponsorship.

<u>Mayor Miller's Report</u>: The Mayor brought attention to a model of Mount Jackson that was on exhibit in the council chamber. The model was created by the GATE class consisting of 3<sup>rd</sup>, 4<sup>th</sup> and 5<sup>th</sup> graders at Ashby Lee Elementary School. The project took a year to complete and will remain on display in the town office until late July. The Mayor also reported that the Stonewall Jackson Varsity Baseball team competed in the state championship against Auburn. SJHS did not win the tournament but did earn the Sportsmanship Award. Mayor Miller announced that two new restaurants are coming to Mount Jackson. Sal's in Edinburg is opening up an Eatery where the old Jalisco Restaurant once was. Another project, which is in the early stages, is to have a brew house and restaurant at the old Triplett School on the east side of Route 11 at the south end of town.

<u>Town Attorney Report</u>: In regard to the annual Organizational meeting, the Town Charter instructs the appointment of specific positions for the Town of Mount Jackson to take place at the <u>first</u> <u>regular meeting</u> in July which will be July 11, 2017. Officers will carry on until that regular meeting takes place as will the Vice Mayor.

<u>Chief of Police Report</u>: To protect the covered bridge, VDOT now has a barricade on Wissler Rd. on the Rt. 11 side and a second barricade on the west side at the sharp curve. "Our goal is to save our bridge."

<u>Town Manager Report</u>: The playground equipment, bench swing, shade cover and zip line are installed at the park.

<u>Committee Reports</u>: Finance Committee Chairman, Rod Shepherd gave high compliments of praise to staff concerning the audit report. Mr. Shepherd highlighted pages 12, 13, 27, 28, 43, 44, 45 & 75 of the report and made a motion to accept the audit report from Robinson, Farmer & Cox for the Town of Mount Jackson's fiscal '16 audit.

Public Safety Committee Chairman, Roger Rudy reported that the police department had 356 calls since April which was a big drop. Out of 27 offenses, 23 are closed and 4 are under investigation. Keith Cowart is a newly hired police officer who joined the force in May. Open windows and doors continue to be a problem. The police department has done 117 property checks which is a great service for the community while people are on vacation. The Mount Jackson Rescue and Fire Dept. had 79 total responses in the month of May. Councilmember Rudy highlighted that because of the availability of a full volunteer crew, the response time is shorter. This was proven at a recent structure fire on Lutz Hollow where there was minimal damage.
