Town Council Meeting Regular Meeting September 12, 2017

The regular meeting of the Town of Mount Jackson Town Council was held September 12, 2017 at 7:30 p.m. in council chambers at 5901 Main Street. Roll call was taken with the following in attendance; J. Bucky Miller, Mayor; Whitney Miller, Donnie Pifer, Roger Rudy and Rod Shepherd, Councilmembers. Councilmembers Andrick and Hackenbracht were unable to attend. Also in attendance, Kevin Fauber, Town Manager; Neil Showalter, Finance Director; Matt Akers, Town Attorney; Jeff Sterner, Chief of Police and Heather Taylor, Town Clerk. Approximately 9 people from the community were in attendance.

<u>Visitors</u>: Mr. Bill Ryan, who was the only visitor to sign the visitor log to speak, was invited to share by the Mayor. Mr. Ryan said he preferred to speak later in the meeting after item #2 under Old Business was discussed.

Mayor Miller stated in his report that the sidewalk project was coming along. He also gave a reminder about the upcoming Mount Jackson Apple Harvest Festival at the end of October and he thanked Heather Taylor for her work with the function.

<u>Town Manager Report</u>: Kevin Fauber said that other than the TW3 report from 9/8/17, he had nothing more to add.

<u>Committee Reports</u>: Councilmember Shepherd, Chairman of the Finance Committee, reported that the auditors have been scheduled to come in.

Councilmember Rudy, Chairman of the Public Safety Committee, reported that Rescue & Fire had 92 responses last month. The department is having a breakfast the morning of the festival, 10/28/17 at the fire department and a steak dinner is scheduled for 10/14/17. Mr. Rudy's brother, Raymond, was visiting a few weekends ago and went for a tour of the fire dept. building with D. Painter and was very impressed. Raymond was a volunteer for the same dept. in the 1970s. The police department had 468 calls in August which was down 36 calls from July. There were 15 criminal reports, 11 of those have been cleared and 4 are under investigation. Five open doors were found this month by police officers which does show that people are being more careful.

Councilmember Miller, Chairman of the Public Properties Committee, reported that the pool has closed for the season. She was emailed by pool staff with hopes, wishes and needs for next year's season.

<u>Old Business</u>: 1. 6044 LLC, (Contract Purchaser), 6044 Main Street, (Old Triplett School Property), Subdivision Application for Parcel 91A1-A-259, 4.038 acres, 16 Lot Subdivision for duplex homes. Kevin Fauber introduced Charlie Moore who is handling the zoning details on the project and is not a partner with the purchasers. Minor variations had recently been made to some of the homes to avoid a slope as well as utility lines and a town well that is located in the center of the subdivision. Last month the BZA approved the rezoning. This was also approved at last night's Joint Public Hearing. The street review by VDOT is 75% complete and they have expressed a general consensus. Motion made by Councilmember Shepherd to approve this application, seconded by Councilmember Miller.

2. The Knob Acquisition Discussion-Heather Richards, Conservation Fund. Ms. Richards was unable to attend due to an emergency but sent the following email.

Rod and Charlie – I am, unfortunately, not going to be able to make it to the meeting tonight due to an animal emergency here at home. Here is my update so far:

1 – Shenandoah County's Board of Supervisors has asked that we work through the Conservation Easement Authority to request funding for the project. Kim Woodwell and I will hopefully be presenting to them on 10/4.

2 – I have two promising potential major donors to the project, but I will likely not have a definitive answer from them until October or November. If they both commit, we could have \$15-20K from them, combined.

3 – Kim Woodwell and I are working on a local marketing campaign to raise more local funds. I estimate that this could net \$5000-7500.

In summary, I still only have \$25K in hand for the project, and still need \$50K to make the acquisition happen. However, I have prospects of \$20-25K in the works and will know more on those later this fall. It would be very helpful for the Town Council to make a financial commitment to the project tonight, as I'll be able to use that to leverage the remaining funds, and hopefully get the County to chip in some money as well.
