<u>Town Manager Report</u>: Kevin Fauber spoke, just when you think winter is done, you get a call from VDOT for our guys to load the trucks back up then nothing happens and a week goes by another forecast for snow. We have been busy putting equipment on and off trucks. The Sidewalk Project is wrapping up. There will be a fence installed over the end-wall at the north end of town and fencing at French's field. The Well 7 & 8 is out to bid, the bid opening will be April 18th. The Little League had their opening ceremonies. The Little League score broad that was struck by lightning last fall, was replaced with a new score broad and working in time for the new season.

Committee Reports: Chairman of the Public Safety; Councilmember Rudy, the Police Department for March, totaled 447calls for March up by 101 calls from February. There were 8 Criminal Offense's, 4 have been cleared or closed, 4 are still under investigation, 3 open doors from 3 different locations last month. Fire and Rescue Report for March, total responses 87 down 10 from February, total EMS responses 62 down 16 from February, total Fire responses 25 up 6 from February. The Easter Breakfast, Bake Sale and Egg Hunt were very successful. They fed 306 people for breakfast and sold 9 tables of bake goods during the event. There is a Steak Dinner to be held on May 12th, 2018 from 4pm-7pm. Tickets are \$16.00 each. The Fire and Rescue Department will be hosting Meet the Candidates April 24th from 7pm – 9pm at the Event Center.
