Public Hearing

Ordinance O-03-19 - Repealing Ordinance O-02-19 and Re-Enacting as Ordinance O-03-19 - Fire Lanes/Fire Apparatus Access Roads. Mr. Showalter stated this new ordinance adds more structure, section numbers, etc., to the previously passed ordinance.

Ordinance 0-04-19 – Amend and Reordain Chapter 66 Zoning, Section 66-62(b)(4) pertaining to the uses permitted by special use permit in an R2 zone by adding Small Scale Solar Energy Facility as accessory use to a School. Mr. Showalter stated staff determined the Town's code needed to be amended to allow this type of solar energy usage after reviewing information regarding the recent Triplett Tech announcement.

Ordinance 0-06-19 – Amend and Reordain Chapter 22 Environment, Section 22-48 by adding paragraph (h) to establish specific penalties for violations related to the storage of inoperable vehicles. Mr. Showalter stated this ordinance is intended to impose additional penalties for the police department to use in administering the inoperative vehicle code.

There were no public comments. Mayor Pifer closed the public hearing.

The regular meeting of the Mount Jackson Town Council was held December 10, 2019, following the public hearing, at 7:30 PM in the council chambers at 5901 Main Street. 3. Mr. Showalter stated the need to add a closed session to discuss a real estate matter, with no announcement expected afterwards.

Hear from Visitors:

- 1. Karen Costie spoke on two things. First, on December 2 she discovered a water leak in front of her house. She called the town office and within 20 minutes public works arrived and worked all afternoon fixing the problem. As they were finishing up she asked if they could clean up the mud, and was told they planned to return the next day with equipment to take care of this. She explained her neighbor was having a party that night and guests would need to park where there was mud, so public works staff stayed beyond normal working hours cleaning it up immediately. Ms. Costie wanted it noted on public record her appreciation for this thorough and prompt service. Secondly, Candi LoPresti asked her to speak tonight on the Holiday Homes Tour this weekend. Ticket sales have been slow so they encourage everyone to spread the word, and asked if members of the council could stop in the Visitor's Center where tickets are being sold, to make an appearance and welcome guests.
- 2. John Boor stated the Christmas Parade is this Saturday, December 14 at 3:30 PM with approximately 20+ entries, and the Stonewall Jackson cheerleaders will lead the parade. Santa Clause will spend an hour before the parade at the Curtain Call Café, and an hour after the parade at the town hall visitor's center. Mr. Boor stated himself as well as visitors in his shop, are positively commenting on how beautiful the town is decorated this year. Mr. Boor stated he's been getting more involved with county tourism, and Jenna French and Brenda Black provided him with some flyers showing maps of the county and the individual towns, with points of interest. He asked councilmembers to take a look at the map to add more points of interest for our town, as there are currently only two, before his next county tourism meeting Tuesday, December 17. He also feels we should start thinking about a town bicentennial celebration, which will occur in 2026. Lastly, he stated the Hometown Partnership celebrated its one year anniversary this month, and is pleased with its success and happy to be working with the town.

<u>Remarks from Councilmembers</u>: Councilmember Good stated discussions are underway regarding upgrading to electronic water meters, with one bid in and hopefully another one to arrive this week.

Chief of Police Report: None

<u>Town Manager Report</u>: Mr. Showalter referred to #3 on the report in the town council packet. The amended VRA Loan and Grant that was approved last month will be closing next Wednesday. Mayor Pifer, the clerk and he will need to sign documents. The group decided to schedule the signing for Monday, December 16 at 1:00 PM. Mr. Showalter stated staff has been working on a system for improving site plan reviews by developing a checklist and work aid that will help give some formality and structure to the review process. He stated the town has to take the lead to advocate for the applicants to make sure the process moves along quickly and

correctly. Mr. Showalter advised that the EDA held a meeting last month and appointed Debbie Stover as Secretary, and he in his role as Finance Director was appointed as Treasurer, and will meet tomorrow for the purposes of electing a current year chairman and vice-chairman, considering approval of both an updated term sheet for potential borrowers, and a façade enhancement grant program. Mr. Showalter stated the town office will be closed December 24-25, and January 1. Mr. Paxton added in regards to the EDA, the town has a unique opportunity with the revolving loan and enhancement program to attract new businesses and staff will work with the EDA to formulate a marketing strategy to reenergize this.

Town Attorney Report: None

Committee Reports:

- 1. Finance Committee Chairperson, Rod Shepherd stated due to recent changes in our staff, the audit presentation that usually occurs in December, will be in January or February in time for budget season in April.
- 2. Ordinance Committee Chairperson, Dennis Andrick had nothing to report.
- 3. Personnel Committee Chairperson, Roger Rudy stated advertisements appeared in two local papers for the Finance Director position, and staff is also networking with our audit firm, and an accounting firm in Harrisonburg to help with this search.
- 4. Public Safety Committee Chairperson, Judy Fultz, reported November Police Department calls were 731, down 13 from October. There were 8 criminal offenses, 3 under investigation, 3 cleared by arrest, and 2 closed due to leads were exhausted. They conducted 550 extra patrols and property checks, and 21 foot patrols. Mr. Painter gave the Fire and Rescue report, stating in November there were 78 responses, 54 EMS and 24 Fire, with 65% were answered by volunteers and 37% of the EMS calls were capable of providing advanced life support. The average transport distance was 10.2 miles, with 24 people taking calls and 51% of the calls were in the town of Mount Jackson. The event center hosted 5 events, with 18 volunteers and 205 hours. On December 21, Santa Clause will ride on a fire truck through the streets in town for the 2nd year in a row, and the Breakfast with Santa event served 362 people.

- 6. Public Properties & Facilities Committee Chairperson, Whitney Miller was absent.

4. Construction of Equipment Storage Structure

Mr. Showalter referred to a memo with attachments in the council packet regarding an emergency, urgent need to house some of the new emergency equipment recently purchased (generator/pump/etc.). Staff noted that the need for this facility is more urgent than enclosing the structure that houses the dump truck at the end of the sewer plant (money was set aside for that work). He stated the proposal tonight is to seek approval to issue a purchase order to Kennedy Konstruction for \$65,807 to build an enclosed and heated pole shed for this purpose, which would also take some storage relief off other maintenance areas. Town staff received two competitive bids for this work.

5. Approval of Zoning Administrator waiver of 7-day requirement for submission of Bowman Andros – New Factory final site plan for approval by the Planning Commission on December 2, 2019.

Mr. Showalter referenced a memo in the council packet pertaining to Bowman Andros submitting the final site plan for the new plant. The previous preliminary plan didn't include information required by some of the other regulators (VDOT and Shenandoah County), which prevented Bowman Andros from getting building permits. According to the town code, site plans are required to be submitted seven (7) days in advance of the Planning Commission meeting. This time period is to provide sufficient time for staff to review the plans and seek input from the other agencies. Much of that review was done at a joint meeting held in late November. Greenway Engineering worked diligently to provide a final site plan drawing within the required schedule, but due to the latest of the joint meeting and timing with the Thanksgiving holiday, it was not submitted to meet the 7-day requirement in the zoning code. The Planning Commission concurred with the Zoning Administrator's decision to waive the 7-day requirement and approved the final site plan, subject to VDOT's comments.

6. Mr. Showalter referred to item 1 of the town manager report regarding VDOT's requirement for a public hearing to consider Resolution R-03-19 regarding Commonwealth Transportation Board's project for the south main street sidewalks. He stated that Steve Damron with VDOT advised that the next regular meeting on January 14 is too close to the Commonwealth Transportation Board's meeting on January 15 to get the documentation included in the final packet. Mr. Showalter recommended having the public hearing on or before January 7. Mr. Paxton added there is no advertising notice requirement for this project, so this hearing can be held as soon as possible. Councilmember Shepherd asked if this public hearing could also include discussion on Phase II of the north end sidewalk project. Mr. Showalter said Karl Schaeffer has received VDOT comments and is meeting with staff tomorrow. Mr. Paxton stated if Mr. Schaeffer advises that a public hearing is required, staff will add that item to the public hearing.
